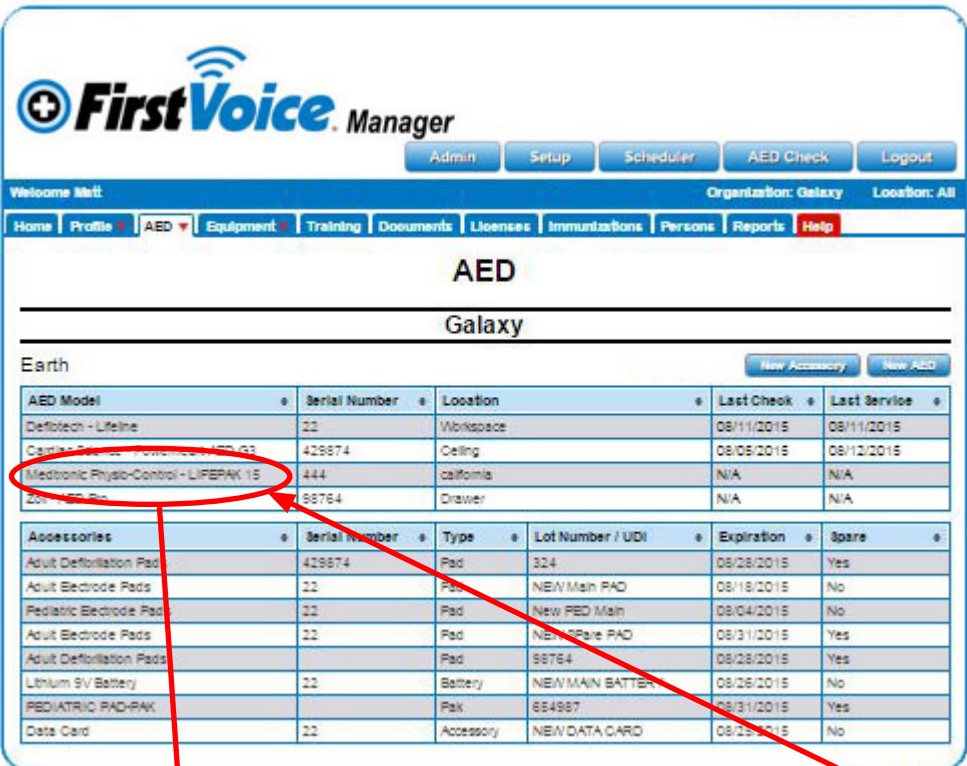


Use with ANY internet ready mobile device or PC!

EASY-TO-USE INTERFACE
 1. The program has windows to see top-down organizational views of AED locations or expand to see summary details by location.

2. The browser scroll bar is used to scroll down to see any aed location the signed in user is allowed to view.

3. Clicking on the AED at each location opens up a new popup window to view details on the AED at that placement location.





UNLIMITED ACCESS

There is no limit to the number of users that can access the database. All locations and organizations are assigned privilege-based user logins.

REDUNDANCY

All users receive pertinent communication on ALERTS (upcoming items or past-due items) or REPORTS that are relevant to their user privileges. Auto-notifications of these make the

program an effective contingency planning tool. This provides redundancy in record keeping and data backup for your entire first aid or safety program as it relates to your in-house equipment and any related training or maintenance needs.

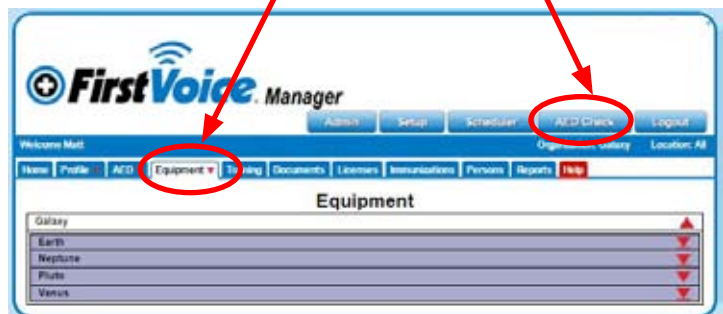

INSPECTIONS & MAINTENANCE

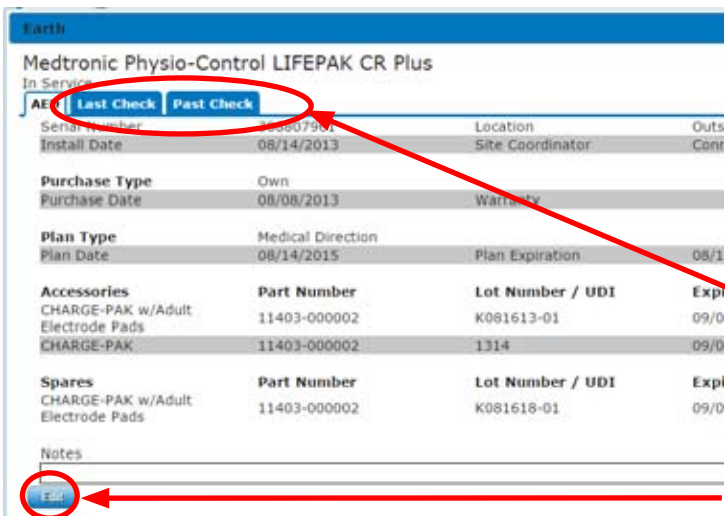
AED (or any other equipment) inspections can be logged using the program. Online inspection checklists can be completed using mobile devices. Log reports of these inspection checks can be easily viewed.

NOTE: The software can be used for recording any “maintenance checks”.



CUSTOMIZABLE INSPECTION CHECKS

The software lets the user input their own default inspection checklist for any logged equipment. This ensures any onsite servicing or maintenance is done to your specs and documentation needs! This also helps limit your liability and verify your organization has maintained the AED or other equipment to manufacturer and industry specifications.



QUICK-VIEWS OF SERVICE & INSPECTIONS

Any AED logged in the software can be easily referenced under the AED check tab to see recent service or maintenance history and current status of consumable expirations and Serial Numbers.

Recent service and maintenance history is under 'Last Check' and 'Past Check' (last ones performed) or a complete log of service history for that AED location is under Reports.

When equipment is moved it allows editing to switch AED to different location. Thus, equipment maintenance history follows the equipment and is not location dependent (great for mobile deployments or large AED deployments).

TRAINING

All personnel trained for your organization in the AED, safety or first aid program can be imported and tracked going forward. Any training they have taken can be entered and tracked!

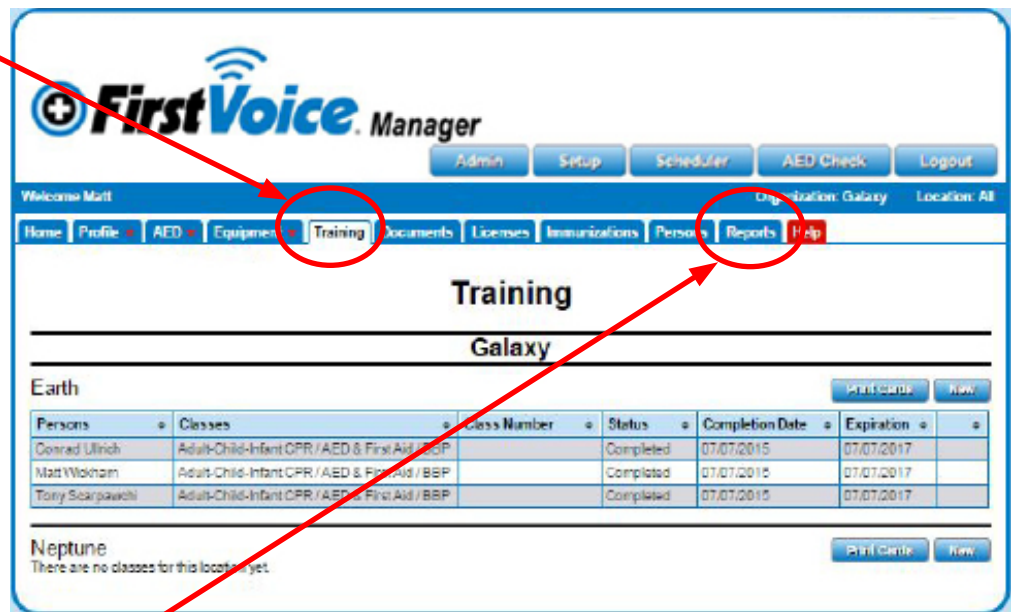
Alerts and reports notify the end user and the organization coordinator about upcoming or past due courses to take.

Allows for redundancy reporting, even if your facility already has a tracking system.

Training from the First Voice Training portal automatically is uploaded to alleviate data-entry workload for your organization. Training rosters can be uploaded (.csv or .xls file) into the software by course/class to alleviate workload.

REPORTS

Reports show current trained, past trained (old certifications that expired) and upcoming training needed. Reports provide information on AED placements and locations, any equipment (and tracking requirements of the equipment) in the system, any AED non-compliance (consumable expirations or inspections past due), any or all AED or equipment inspection logs, equipment non-compliance (consumable expirations or inspections past due), and any upcoming expirations for any part of the program.

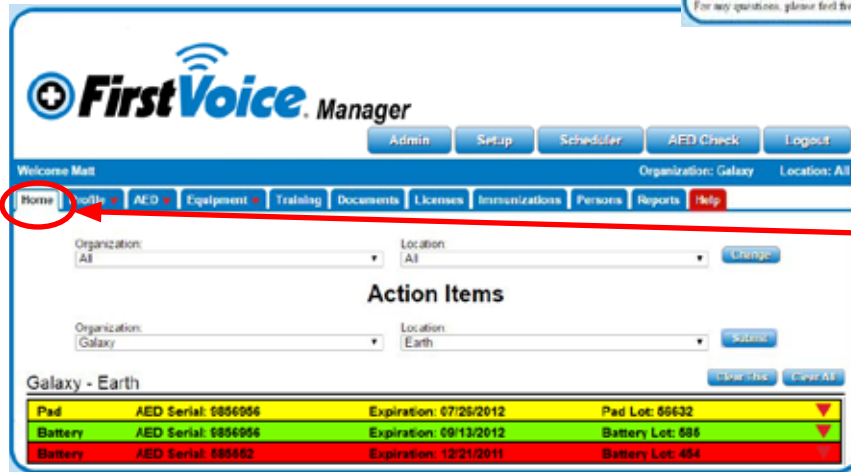


HIERARCHY

The program has several levels of hierarchy so anyone from VIEW ONLY users to EDIT users with access to only one location to numerous locations can be granted. MANAGEMENT (Administrative User) privileges allow higher-level top-down reporting and monitoring as well.

COMMUNICATION

All or select users for an organization can be set up on auto-notifications for recalls or reminders, and any alerts or non-compliance issues.



URGENCY / ALERTS

Immediately upon login, the Home Screen shows any immediate action items that need to be addressed. Screen print to the left shows **action items** upcoming – this is the first screen seen upon LOGIN to ensure they are addressed promptly.

Only those items that pertain to the USER that has logged in will be shown!

MEDICAL OVERSIGHT DOCUMENTATION

Access upgrades allow for AED program compliance administration and medical oversight information archives.



LICENSING

Annual license fee is the preferred billing plan. Monthly or multi-year pricing are available, subject to approval.
